#### 1. Purpose and application

- 1. This Regulation on social support measures for students at D. Serikbayev East Kazakhstan Technical University (hereinafter the Regulations) aims to support students with a high level of training and / or belonging to socially vulnerable population, and defines the procedure for providing social support.
- 2. The Regulation is developed according to the Law On Education, based on the Resolution of the Government of the Republic of Kazakhstan dated February 7, 2008 № 116 On approval of Rules of assignment, payment and amount of state scholarships to students of educational institutions (as amended on 03.09.2021).
- 3. The contract for the reimbursable provision of educational services and / or the procedure of enrollment students, undergraduates, and postgraduates serves as a basis for applying the norms of this Regulation.

The Regulation is considered by the Academic Council and approved by the Chairman of the Board-Rector of the University.

The requirements of the Regulation are mandatory for all structural subdivisions of D. Serikbayev East Kazakhstan technical university.

4. It is an internal normative document of EKTU and is not subject to presentation to other parties, except for auditors of certification bodies during inspections of the quality management system, as well as to consumers-partners (upon their request) with the permission of the Chairman of the Board-Rector of EKTU.

#### 2. Normative documents

- 5. The following normative documents were used in drafting the Regulation:
- 1) Law of the Republic of Kazakhstan On Education of 27.07.2007, No. 319-III.
- 2) Order of the Minister of Education and Science of the Republic of Kazakhstan dated October 31, 2018, No. 600 On approval of the standard rules of admission to education institutions implementing degree programmes of higher and postgraduate education (as amended and supplemented as of 05.11.2021)
- 3) Standard rules of education institutions implementing degree programmes of higher and (or) postgraduate education are approved by Order No. 595 of the Minister of Education and Science of the Republic of Kazakhstan dated October 30, 2018 (with amendments and additions as of 29.12.2021)
- 4) The Charter of the NJC D. Serikbayev East Kazakhstan Technical University was approved by order of the Chairman of the Committee of State Property and Privatization of the Ministry of Finance of the Republic of Kazakhstan dated 02.06.2020 No. 345.

#### 3. Terms and definitions. Abbreviations

- 6. The terms of the Regulations shall have the following meaning;
- 1) social support measures are benefits provided by the University for certain categories of students (orphans, students with special educational needs, low-income and multy-children families, etc.);
- 2) the commission is a collegial body composed of university staff whose competence includes the examination of submitted documents from applicants for social support measures;
- 3) a low-income family is a family whose total income over a certain period of time does not meet the minimum cost of living (to confirm the status of the applicant as a low-income family, the student provides a document of appropriate form from the Employment Centre);
- 4) A multy-children family is a family with four or more underage children living together, including those enrolled as full-time students in secondary, technical and vocational, post-secondary, higher and (or) postgraduate education institutions after reaching the age of majority until the end of their education period (but no older than the age of twenty-three).

#### 4. Social support measures

- 7.Social support measures for students of D.Serikbayev East Kazakhstan Technical University:
- 1) benefits and discounts on tuition fees for different categories, and students (Appendix 1 and 2, approved at the beginning of the academic year);
- 2) social (financial) support for students from different categories (Appendix 3, approved at the beginning of the academic year).
- 8. For consideration of the submitted documents on their completeness, validity and legality the commission from among employees of university whose competence includes consideration of the submitted documents from persons applying for measures of social support is created. The members of the commission shall be approved annually by order of the Chairman of the Board-Rector of EKTU.

#### 5. Amount and procedure for benefits and discounts

- 9.Benefits, discounts and categories of persons entitled to receive them are defined in Appendices 1 and 2 to the present Regulation.
- 10.Benefits and discounts to persons enrolled in doctoral degree program on a contractual basis are considered on an individual basis.
- 11. An applicant to D. Serikbayev East Kazakhstan Technical University (hereinafter referred to as University) or Higher D. Serikbayev EKTU IT-College (hereinafter referred to as College), claiming for benefits and discounts, applies with a written application

(Appendix 4) to the Chairman of the Board-Rector with attached package of supporting documents to the admissions committee until August 25 of the year.

- 12.A student continuing his/her studies at the University or College who claims benefits and discounts shall apply with a written application (Appendix 4) to the Chairperson of the Board-Rector and a package of supporting documents to the Student Services Centre (SSC) by September 30 of the current year.
- 13. Lists, applications and supporting documents of students applying for benefits and discounts shall be submitted by the Chairperson of the Admissions Committee, Deans of Faculties/Schools of the University, and Director of the College to be considered by the Commission.
- 14. The Commission schedules a meeting within five (5) working days of a student's admission to the University.
- 15. During the meeting all the members of the commission shall review the documents of the applicants for benefits and discounts in an open, transparent and free-flowing environment. Regarding the documents, the minutes of the commission meeting shall list persons applying for benefits and discounts. On the basis of the minutes, the SSC issues an order for the granting of benefits and discounts, specifying their amount and duration.
- 16. Only one type of benefits and discounts may be applied simultaneously to the established tuition fees. If a student is entitled to benefits and discounts in several categories, the maximum is granted.
- 17. In case of payment of student's expenses for the entire period of training at the time of conclusion of the contract, the amount of payment is fixed until the end of the training period.

#### 6. Amount and procedure for the provision of social (financial) support

- 18. Social (financial) support is granted for a period approved by order of the chairman of the board-rector.
- 19. A student applying for social (financial) support shall submit a written application (Appendix 5) to the Chairperson of the Board-Rector with all necessary documents attached to the UniversityStudent Service Center.
- 20. The commission review the given documents to consider if they are complete, valide and legal.
- 21. The Commission shall consider all documents in an open, transparent and free-flowing manner. On the basis of the documents examined, a protocol of the commission's meeting indicates the list of applicants for social (financial) support measures. This protocol is of advisable character and is submitted to the Chairman of the Board-Rector of the University.

#### 7. Grounds for extension and/or termination of social support measures

- 22. Social support measures are provided for one academic year or the entire period depending on the category (Appendix 1, 2), provided that the student has completed the current semester with a GPA not lower than 3.0. In case of completion of the current academic period with a GPA of less than 3.0, the granted social support measures shall be withdrawn from the subsequent academic period.
- 23. Social support measures for College students are provided for one academic year or the whole training period depending on the category (Appendix 1, 2), provided that the student has completed the current semester with grades not lower than "4" (good). In case of completion of the current semester with grades less than "4" (good), the social support measures are terminated from the following semester.
- 24. It is possible to provide social support for students in categories 2, 3, 6 of Appendix 1 and category 3 of Appendix 2 of the Regulation, for the next term, regardless of academic performance.
- 25. The Chief Accountant, the Deans of Faculties/Schools, the Registrar's Office, the Director of the College, and the Chairman of the Admissions Board are responsible for the timely preparation and correct execution of documents.
- 26. The member of the Vice-Rector for Academic Affairs is responsible for monitoring the execution of the Regulation.


